VILLAGE OF SPARLAND ORDINANCE NO. 25 -

AN ORDINANCE APPROPRIATING FUNDS FOR THE VILLAGE OF SPARLAND, MARSHALL COUNTY, ILLINOIS FOR THE FISCAL YEAR BEGINNING MAY 1, 2025 & ENDING APRIL 30, 2026

BE IT ORDAINED by the President and Board of Trustees of the Village of Sparland, Marshall County, Illinois as follows:

<u>Section 1</u>. The amounts hereinafter set forth, or so much thereof as may be authorized by law, and as may be needed or deemed necessary to defray all expenses and liabilities of the municipality, be, and the same are hereby, appropriated for the corporate purposes of the Village of Sparland, Marshall County, Illinois, as hereinafter specified for the fiscal year beginning May 1, 2025 and ending April 30, 2026.

<u>Section 2</u>. The appropriation herein made for any purpose shall be regarded as the maximum amounts to be expended under the respective appropriation accounts and shall not be construed as a commitment, agreement, obligation, or liability of the Village of Sparland, and such appropriation being subject to further approval as to expenditure thereof by the Village Board.
