

ORDINANCE NO. 2021-11

An Ordinance Amending Ordinance #05-14, as amended, and Rates and Charges for the services of the waterworks and Sewerage systems of the **VILLAGE OF SPARLAND**, Marshall County, Illinois.

WHEREAS, the Village Board of the Village of Sparland, in the County of Marshall and State of Illinois has considered in open session the modification of the established fees for connection to the Village's waterworks and sewerage systems;

AND, WHEREAS, the Village Board has determined the existing fees should be incorporated into the Village's ordinance establishing rates and charges for the use and service supplied by the waterworks and sewerage systems, and that said ordinance should be restated with said modifications;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND VILLAGE BOARD OF THE VILLAGE OF SPARLAND, MARSHALL COUNTY, ILLINOIS, AS FOLLOWS:

SECTION ONE: There are hereby established rates and charges for the use and availability of, and for the service supplied by, the waterworks and sewerage system of **VILLAGE OF SPARLAND**, Marshall County, Illinois, based upon the fixed costs and expenses of the system, and the improvements required to bring said systems into compliance with the IEPA regulations, as follows:

- A. One Family Unit:** *A minimum charge for Water service of: \$41.00*
A minimum charge for Sewer service of: \$19.50
****Starting in July 2020 an additional \$5.50 raise***
(Water Service \$41.00 and Sewer \$25.00)
- B. Business or Commercial:** *A minimum charge for Water Service of: \$41.00*
A minimum charge for Sewer service of: \$19.50
****Starting in July 2020 an additional \$5.50 raise***
(Water Service \$41.00 and Sewer \$25.00)
- C. School District # 7** *A minimum charge for Water Service of: \$266.00*
A minimum charge for Sewer Service of: \$634.00

SECTION TWO:

All ordinances or parts of ordinances not in conflict herewith are hereby affirmed.

SECTION THREE:

All ordinances or parts of ordinances in conflict herewith to the extent of such conflict are hereby repealed. If any section, paragraph clause or provision of this ordinance shall be held to be invalid or unenforceable for any reason, the invalid or unenforceable section, paragraph, clause or provision shall not affect any of the remaining provisions of this ordinance.

SECTION FOUR:

This ordinance shall be in full force and effect upon its passage and publication as provided by law.
